As a Quality Assurance intern, you will gain exposure and experience in a wide range of Quality Assurance activities including Complaint Management, Investigations, Root Cause Analysis, Validation and Auditing. Duties will include some of the following:

- Supporting the complaint management process. Monitoring trends, following up with consumers and distributors, performing and documenting investigations.
- Supporting production investigations and non-conformances.
- Checking batch records of manufactured batches.
- Supporting validation activities for production and laboratory operations.
- Supporting inspection readiness by regulatory authorities against ISO 13485 and ISO 22716 standards. Review of procedures, training, self-inspections.
- Supporting audits of contract manufacturers and suppliers and working with them to resolve any non-conformances.
- Exposure to project meetings and discussions with various other departments in the business.
